**AMENDMENT TO DECLARATION ESTABLISHING EASEMENTS,  
COVENANTS, CONDITIONS, AND RESTRICTIONS**

A Declaration Establishing Easements, Covenants, Conditions, and Restrictions was recorded on February 9, 1979, in Book 13031 pages 27-51, in the office of the County Recorder for the County of Orange, State of California. Said Declaration encumbers lots 1-77 of Tract 9604, as shown on the Tract map recorded on July 17, 1978 in Book 436 at Pages 17-22, inclusive, of the Official Records of the County of Orange, State of California;

The Declaration has been amended twice. The first amendment was recorded on May 7, 2003 as Instrument No. 2003-00519458. The second amendment was recorded on October 24, 2008 as Instrument No. 2008-000490804.

The Declaration provides in Article VII for the establishment of an Architectural Committee that is granted specified powers. Article VII, Section 4(b) provides that the powers and duties of the Architectural Committee shall cease on and after forty (40) years from the date of the recording of the declaration, unless within one year prior to said date, a written instrument shall be executed and duly recorded by the then Owners of a majority of the Lots then subject to the declaration, appointing a representative or representatives and granting any and all authority and powers vested in the Architectural Committee;

The Owners of a majority of the Lots have approved an extension of the powers for the Architectural Committee and have executed a written instrument authorizing an amendment to this provision and authorizing the Board of Directors to continue with the power to appoint Members only to serve on the Architectural Committee as provided in the original declaration;

A copy of the written signatures of the Owners of at least a majority of the Lots is attached hereto as Exhibit "A".
